## MINUTES

Called meeting of the above-named council was held on  
October 28, 2025, at 1:30 p.m. at the Sunrise Beach Village Civic Center,  
124 Sunrise Drive, Sunrise Beach, TX 78643

**1. Call to Order and Establishment of Quorum.**

*Council was called to order by Mayor Rob Hardy who announced a quorum was present. Mayor Pro Tem Rick Bruns was present along with Councilmembers Dan Gower, Mike Byrd, Jeff Cook and Steve Primm. Also in attendance were Police Sgt. Steve Harris, Police Chief Laurie Brock, Comptroller Sandy Peshorn, and Water Department Supervisor Sean Schriebner.*

*Item presented by Mayor Hardy. Motion to approve made by Councilmember Byrd, seconded by Councilmember Gower. Unanimous Vote. Motion Passed.*

**10. Discussion and/or Possible Action on letter of approval for alcohol sales by CCAA for Sip & Stroll November 8, 2025. (Hardy/Guest)**

*Item presented by Mayor Hardy. Discussion included statement made by citizen Tracy Ward, who said she felt selling alcohol at public events and specifically at 9 am would promote alcoholism. Motion to approve made by Councilmember Gower, Seconded by Councilmember Byrd. Unanimous Vote. Motion Passed.*

**11. Discussion and/or Possible Action on purchase of building located 3933 Ranch Road 2233.**  
*Item was introduced by Mayor Pro-Tem Bruns. Discussion ensued. Motion was made by Councilmember Cook to not purchase or pursue negotiations to purchase building. Motion was seconded by Councilmember Primm. Vote 2-yes, 3-no., Motion failed.*

*Motion was made by Councilmember Byrd for Mayor Pro-Tem to continue to investigate this purchase and to continue to look at all options, if police department is forced to move and to bring it to council on November 20<sup>th</sup>. Motion seconded by Councilmember Gower. Motion recalled by Councilmember Byrd. Councilmember Gower made a motion to continue considering the purchase of the building and all options of rehousing the police department and to table the action of purchasing the building at this time. Motion seconded by Councilmember Byrd. Vote 2-No, 3-Yes., Motion Passed.*
